To President

V.L. Enterprise Public Company limited ("the Company") would like to clarify the operating results of the Company for the year ended 31 December 2024 as follows:

The operating results for 2024 mainly derived from the oil tanker fleet transportation service business.

Total revenues

For 2024, the Company generated total revenue from fleet transportation service business for petroleum and chemical products, composed of Baht 759.9 million from the freight charges, Baht 57.4 million from gain on disposal of assets, Baht 0.6 million from gain on exchange rate, and Baht 3.2 million from other revenues.

The proportion of freight charges can be classified for 2024 and 2023 as follows:

For 2024, the total freight charges of the Company were Baht 759.9 million, an increase of Baht 17.5 million compared to 2023 or increased 2.4%.

This was caused by an increased in the domestic freight charges and decreased in the international freight charges, this was due to

- Domestic freight charges had increased 7.2% due to, mainly, in 2024 there was an increase of revenue from the newly acquired "V.L. 24" since the 2Q23.
- International freight charges had decreased (6.8%) due to sell of vessels "V.L. 21" in 3Q24.

Gain on disposal of assets

For 2024, gain on disposal of assets of the Company was Baht 57.4 million, the whole amount increased to compared to 2023 due to in 2Q24 the Company has an agreement to sell vessel "V.L.21" with a foreign company, which deliver the vessel and has gain on disposal of such vessel in 3Q24.

Cost of freight

For 2024, cost of freight of the Company was Baht 657.9 million, an increase of Baht 19.1 million compared to 2023 or increased 3.0%. Mainly, due to fuel oil expense, employee expense and depreciation were increase.

Gross profit

For 2024, gross profit of the Company was Baht 102.0 million or gross profit margin of 13.4% of total freight charges, a decrease of Baht (1.6) million compared to 2023 or decreased (1.5%). This was a result of the cost of freight to increase.

Income for the period and total comprehensive income for the period

For 2024, income for the period and total comprehensive income for the period of the Company were Baht 74.8 million and Baht 73.8 million, respectively, an increase of Baht 43.8 million and Baht 42.8 million, respectively, compared to 2023 or increased 141.3% and 138.1%, respectively, due to performance in 2024 and has gain on disposal of vessel V.L.21.

Assets

As at 31 December 2024, the Company reported total assets of Baht 1,663.9 million, a decrease of Baht (236.3) million compared to 31 December 2023 or decreased (12.4%) due to

- Other current financial assets had decreased in the amount of Baht (30.1) million or decreased (37.3%) due to sold Other current financial assets in 2024.
- Vessels and equipment had decreased in the amount of Baht (200.5) million or decreased (12.9%)
 due to sold vessel V.L.21 in the amount of Baht 108.9 million in 3Q24 and there is depreciation of vessel and equipment contained in the account.

Liabilities

As at 31 December 2024, the Company reported total liabilities of Baht 621.7 million, a decrease of Baht (256.9) million compared to 31 December 2023 or decreased (29.2%) due to

- Increase in the total non-interest-bearing debt amounting to Baht 27.5 million or increase 31.1%,
 mainly, were Purchase of fixed assets payable and Other liabilities.
- Decrease in the total interest-bearing debt amounting to Baht (284.4) million or decrease (36.0%),
 in caused of the repayment of the loans and releasing the guarantor of the vessel to proceed with
 the sale of the vessel V.L.21 in amount of Baht 51.50 million. The rest was payment of lease
 liabilities and repayment of loans from financial institutions.

Shareholders' Equity

As at 31 December 2024, the Company reported total shareholders' equity of Baht 1,042.2 million, an increase of Baht 20.6 million compared to 31 December 2023 or increased 2.0% due to there were paid for dividend in the amount of Baht (53.2) million and total comprehensive income for 2024 amounting to Baht 73.8 million.
